Glossary of Terms

A	Arrivals
Background noise level (L90)	The sound level in dB(A) that is exceeded 90% of the time
Correlated Noise Event (CNE)	A noise event correlated to an aircraft operation that flew through the capture zone
Correlation Summary	Percentage of captured aircraft operations correlated with noise events recorded by the noise monitor
D	Departures
Day	6:00am to 11:00pm
H	Helicopters
LAm _{ax}	Maximum sound level in dB(A)
Local	Operation that departs and arrives at the same airport. Local movements include circuits and training flights.
Movement	An aircraft operation, such as an arrival or departure
Night	11:00 pm to 6:00 am
NFPMS	Noise and Flight Path Monitoring System
Noise Event	A noise that exceeds the threshold sound level for longer than the threshold time that is set
NMT	Noise Monitoring Terminal
O	Overflight i.e. an aircraft movement that flew over the area but did not arrive or depart from the airport of concern
T	Local Operation (Departure and Arrival)
Threshold	Determined level on noise monitor that triggers a noise event when exceeded

Deployment Purpose

Short term noise monitoring was conducted at Oxley following recommendations made by the community.

The purpose of this report is to provide a technical summary of the recorded aircraft noise and operational data collected at Oxley during May 2014.

Capture Zone	2.5 km radius with 8,000 ft (above ground level) height for noise data capture

Oxley Findings

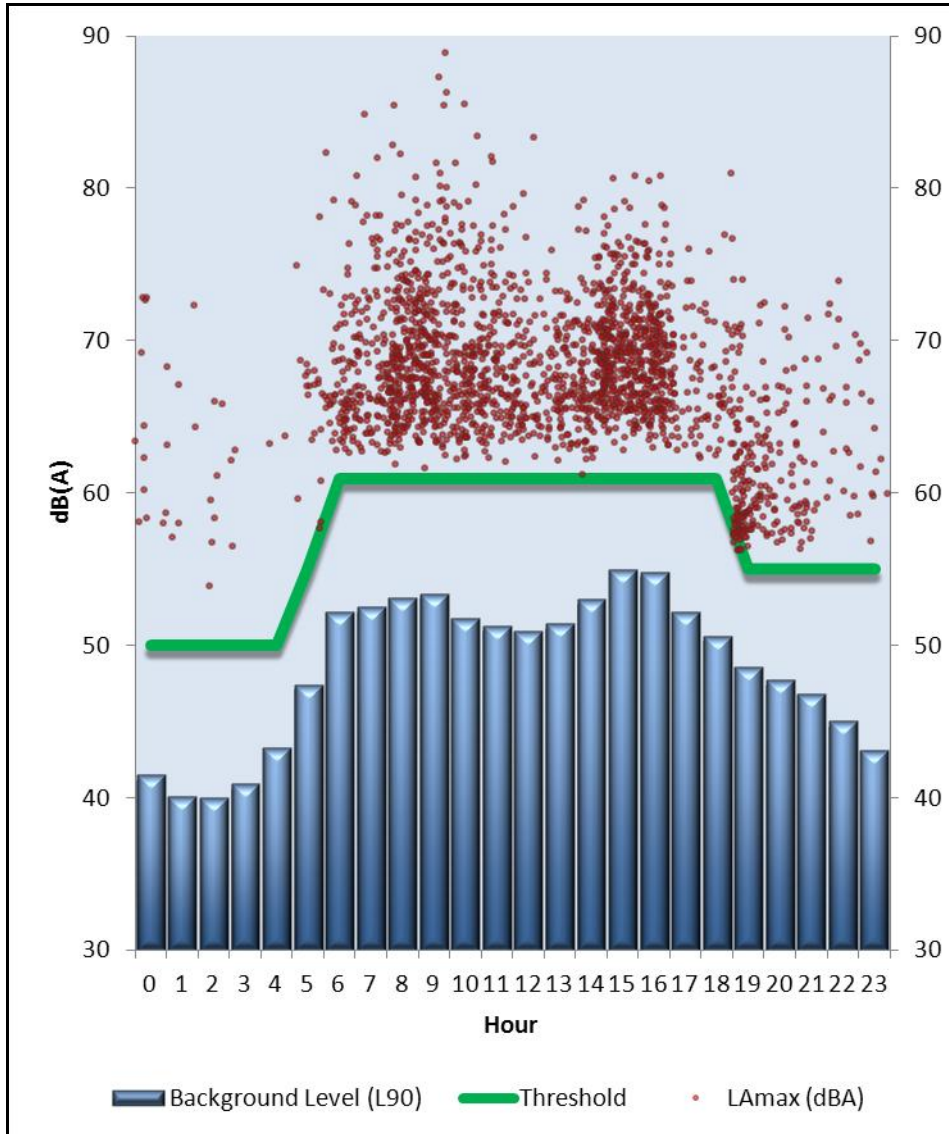


FIGURE 1: OXLEY NOISE SUMMARY

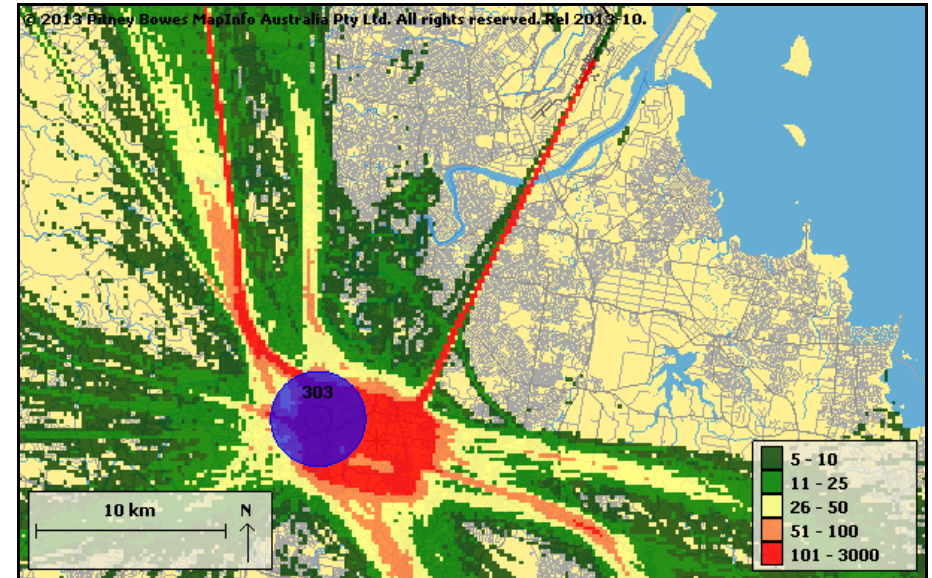


FIGURE 2: TRACK DENSITY OF OPERATIONS THAT TRAVERSED OXLEY

- For more information please refer to Figure 1, Figure 2 and Table 1 on page 4.
- The noise monitor was located in Oxley 2 km west of Archerfield airport.
- 3,000 movements flew through the capture zone during the reporting period. 2,266 of these were Archerfield operations.
- 19% of total operations that flew through the capture zone (as shown in figure 2) were Brisbane airport movements.
- 1,606 correlated noise events exceeded 65 dB(A), 28 of these occurred during the hours of night.
- The number of correlated noise events exceeding 65 dB(A) in any one day ranged from 17 to 88.
- Residents of Oxley experienced 28 correlated noise events that exceed 80 dB(A) during the reporting period.
- The loudest correlated aircraft noise event with a max level of 88.9 dB(A) was an unknown aircraft that departed from Archerfield airport.
- The correlation summary for all movements was 42%. This is considered an average result based on reviews of fixed noise monitoring terminals nationally.

05/05/2014 12:00AM – 02/06/2014 12:00AM
